Hello GA Region,

I attended GRCNA on February 6th in Atlanta. Our H&I workshop was well attended but the speakers failed to show up for the most part for whatever reasons.

We received two cases of Basic Texts from the East Coast Convention to distribute in Prisons in the Georgia prison system. I delivered 10 Spanish and 8 English editions to an RSAT unit in the Piedmont Area. I have provided East end with 6 texts and Savannah Low Country with 6 texts also.

I have received 1 email this quarter from a newcomer in the Marietta Area that wanted to help with the GA Region Bridge Program and 1 phone call dealing with an H&I panel leader from the Piedmont Area. Both requests have been dealt with appropriately.

Today we, our admin panel, failed to assemble. I was without minutes, forms, and trusted servants. We did however have a subcommittee meeting. 5 out of 15 Area's were represented by chairpersons and 2 Areas were represented by proxy (RCM). We had reports from South GA and Central Savannah River of which we are grateful. We are sad to report that the Extreme Northern Area H&I has folded. Savannah Low Country Area will be hosting our Spring of 2016 Regional learning day on May 14th in Savannah. MWBR. I will be requesting the money's for that this Region.

Please ask your Area H&I chairperson to attend our committee meeting. We miss them when they don't show. If they can't make it, they can participate by emailing in an absentee report. The report is found in the report section of our Regional website.

Our admin failed to meet via conference call monthly to hammer out all inconsistencies in our current policy or to nail down a calendar/agenda that can be followed and passed down in the future. We also failed to revise the purpose and function to more closely represent current practices. I apologized to my committee for this and assume responsibility for these shortcomings and I apologize now to this committee also. We have decided to handle these at our Regional H&I Learning day in May. We will bring our revised policy to the next RSC to go over with the Area H&I chairs present.

Once again We will be attaching all forms and procedures for the GA Regional Bridge Program to the RSC minutes. Please make sure all GSR's in your Area's get a packet/copy. If they don't understand the program please contact me for a presentation arrangement.

The GA Region Bridge Program helped 3 inmates last quarter. We've now assisted 108 inmates since February of 2012. Please continue to ask members of your group, ASC and subcommittees to sign up to be a temporary contract on the GRSCNA website.



MOVING THE WEB SERVER TO THE CLOUD

- * With Jim S., we have a web server out on the internet too
- · What is different?
 - We will rent a web server based on the capacity we need right now and not buy extra capacity
- We will have the option to increase that capacity without having to redo our server from scratch
- We will lease the web server from a major technology company Google, Amazon or Microsoft
- We will not be dependent on one person to make changes to the technology behind our web publishing
- We can still host all of the domains for different NA areas, projects (History) and committees (GRCNA)

DATABASE SERVER FOR MEETINGS INFO

VOIP

- The Web server we will most likely use is a LAMP (Linux-Apache-MySQL-PHP) server similar to the one we now use
- A product that we have identified that runs on MySQL database server and is made specifically for our use is BMLT (Basic Meeting List Toolbox)
 - >The main benefit to the solution Jim S. has provided us with is that the areas can login to the region's meeting database and update the information
 - That same information appears on our area web-sites without having to enter it twice
 - ➤BMLT will also work that same way. We will login to the regional server and update our meeting info per area. BMLT has a plugin for Wordpress that will publish that info on the area web-sites
 - ➤In addition, BMLT can be configured to update World Services meeting info and there is an iPhone app for it as well

- We will still host our main helpline for the region and all areas who want to participate out on the web using voice-overinternet-protocol
- Instead of Jim S. hosting it on the same server that does the web hosting, we will move the VOIP to a company that specializes in that and they will provide the technology to host it for us
 - We can afford to do this now because the pricing on hosted VOIP has come down to the same levels as self-hosted VOIP
 - We will be able to choose from leading VOIP Hosted PBX providers
 - If one provider doesn't work to our satisfaction, we will be able to easily move




