### **GRSC Admin Meeting Minutes**

- Administration meeting was moved to 9 am for this quarter due to the 40<sup>th</sup> anniversary celebration and the workshop scheduled 12 pm – 4 pm.
- Mary Ellen, PR chair, was invited and attended the meeting.
- The issues addressed included the need for a webmaster, accessibility and functionality of the regional website, and the possibility to get 2-3 bids for a company to manage the site.
- There was discussion pertaining to our policy and to get the approval of the areas for the updated and current version. Tate has added all of the changes that have been issued by our areas and wants a copy of this version to go to the RCMs. It will be emailed with the minutes and be marked with a watermark stating it is a draft.
- Another concern was the need to revise the definition for consensus in the policy. The current definition leans towards explaining how to not come to a consensus as opposed to coming to a consensus. There was some discussion of Article F with one member bringing in a draft for revising the definition as it is stated there. We will put this to the floor for input from the RCMs. The ad hoc committee for the traditions workbook has contacted all of the RCMs. There have been 2 responses with some effort put forth for a workshop with little interest. Once the submitted work for traditions 1&2 are provided there may be enough interest to set up a workshop.
- It was also discussed and decided that we needed to have a checks and balance system in place for the annual insurance policy renewal. It was decided to add the insurance renewal date to the calendar in the policy and to ask the regional floor for input at the business meeting.
- Another item of discussion was the illegal use of publication material. The admin team deems that the region should not get involved as it is not NA approved.
- The team also addressed the need for the full participation of all the trusted servants in positions on the administrative level. The conference calls will continue as the conscience of the team is that they are a useful tool for our cohesiveness and for managing issues that the regional body asks us to address.

### **GSR/RCM Issues Meeting Minutes**

- GSR from We do Recover group attended and addressed the floor with the following concerns: policy of RSC sub-committees, GSR assembly, groups voting on all policy change, how the region helps the areas.
- Issues discussed included if it be reasonable to have a GSR assembly at each region to get GSRs involved. It was stated that there had been one today which was poorly attended by GSRs. They will be conducted when the admin is asked to have them. It was suggested that Saturday afternoons were a good time for GSRs to come participate.
- It was asked if the RSC sub-committees have policies and if so could they be made available to the groups. The PR stated they did have a policy and it was available to anyone that wanted it. As for H&I, the chair was not present to let us know.
- Concerns were expressed of how the region helps areas to carry the message. It was stated that in the flow of communication from the regions to the areas that the info gets down-sized or isn't forwarded at all. There was discussion about how region is available to the areas and the groups to help them be successful in getting a clear message, but the areas and the groups have not asked for help. Midtown spoke up stating they were moving towards

CBDM and they want help. It was reported that the policy chair from Midtown had contacted the RD/RDA for a presentation but has not gotten back in touch with when and where. Also, West End area asked for a workshop on CBDM as well. The representatives will get the dates and places for these requests to the RD/RDA.

- There was a request for the RCMs to look at the revised definition for CBDM that was prepared (Article F) overnight and bring some feedback during the business meeting on Sunday. The purpose of revising this definition is to assist the RSC body in preparing a finalized product to send back to groups without taking up a lot of time on the local area and group level. The RCMs stated they wanted an ad-hoc committee to be formed to address this.

## **Traditions Workbook Project**

Several questions have come up concerning the Traditions Workbook Project. This project has been discussed around the fellowship for about 20 years. Around 1995 the World Literature committee did an inventory of projects that the regions had been discussing. The regions were asked to prioritize the lit projects. Around 1998-2000 we were going through the transition to the new world service structure. The first we took on was The Sponsorship Book. After that came the PR Handbook the Basic Text Project (4 year project) then Living Clean another (4 year project). Then in 2010 California Mid State Region made a motion to for "The World Board to develop a plan for presentation at WSC 2012 for a Traditions Working Guide". A 2011 fellowship wide literature survey indicated that this is an item that our members are very interested in: Over



80% of respondents said this was an item that was needed or very much needed. In 2012 the plan was approved.

Here is where we are today. The Working Group met last week to begin reviewing the input they have already been receiving on traditions 2-7. They will also be developing the draft for our review of Tradition 1 and the introduction. We will receive that in October and will have until Jan. 31st to review and make our submissions. On February 1st we will receive 2-7 for our review.

I have been told that the response from the overall fellowship has been good. They are taking any feedback that the fellowship has submitted. You are not limited to the questions that I included in my last e-mail. Many groups/areas/regions are promoting a tradition a month. We have heard that there have been two workshops conducted yet in Georgia. If you have organized a workshop please let me and or Tate know so we can pass the word along.

To support you in forwarding your recommendations, here is an RBZ checklist to take into consideration:

- Consider the individual's abilities and their qualifications for the position
- Provide the HRP with comprehensive details of the member's suitability for the position
- Be sure the member is aware of your recommendation
- This is a recommendation, not a nomination

We strongly suggest that service committees speak with the prospective candidate before forwarding their name to the HRP. This will save you time if the person is not interested; and this will also save the HRP time by not having to contact someone whose name was forwarded, only to discover that they are not interested. Any potential candidate must complete or update his or her World Pool Information Form (WPIF). It would be very helpful if your service committee passed along this request to those members. The WPIF is available online at:

<http://www.na.org/?ID=HRP-wpif-default> or by calling or writing to NAWS. Again, we suggest that the above service committees consider any individuals who may be qualified for any of these positions. Detailed discussion of each of these positions can be found in our service manual, *A Guide to World Services in Narcotics Anonymous*. Here is some information from the guide:

### **World Board Member:**

- Ten years continuous clean time.

In addition to the qualities expressed in Concept Four such as humility, integrity, trustworthiness, and strong commitment to open communication, the following qualifications for nomination and election to the World Board are written to express the variety of skills and experience necessary to the board's optimum operation. A single individual may not have all of the qualifications listed below. These qualifications should not be viewed as a list of absolute requirements, but rather as an expression of the qualities and experience that will help the board to best serve our fellowship:

- History of both completing work independently and working well within a group.
- Familiarity with and commitment to the World Service Conference vision of a global fellowship demonstrated through world service or personal life experience.
- Familiarity with the Narcotics Anonymous service structure.

- Administrative skills.
- Experience with plan development and financial forecasting.
- Organizational and communication skills.
- Ability to donate sufficient time to attend meetings, travel, and to fulfill the additional commitments of board membership.
- A working knowledge of the Twelve Steps, Twelve Traditions, and Twelve Concepts.

#### **Human Resource Panel Member:**

- Eight years continuous clean time.

*Membership requirements:* As well as holding no other world service commitments by the time they assume their duties on the Human Resource Panel, all prospective Human Resource Panel members should demonstrate the following:

- Trustworthiness—integrity and the ability to provide leadership (as discussed in our Fourth Concept).
- Discretion—the ability to fulfill their responsibilities with the conference’s confidence that confidential information will be protected.
- Experience—members should possess previous world service experience and should demonstrate some personnel/human resources experience.
- Ability to read English.
- A working knowledge of the Twelve Steps, Twelve Traditions, and Twelve Concepts of Narcotics Anonymous.

#### **WSC Co-facilitator:**

Eight years continuous clean time.

The qualifications for the WSC Co-facilitator are:

- A demonstrated ability to preside over business meetings.
- A working knowledge of WSC policies and procedures.
- A working knowledge of *Robert’s Rules of Order* and general parliamentary procedure.
- Demonstrated organizational skills.
- Holding no other world service positions or responsibilities at the time of assuming the Co-facilitator’s duties.
- A working knowledge of the Twelve Steps, Twelve Traditions, and Twelve Concepts of Narcotics Anonymous.

Once your service committee has agreed to forward a name (or names), keep in mind that the deadline for receiving the information is **31 October 2015**.

### **Conference Cycle Projects**

**WSC Processes:** virtual workgroup that will hold its initial virtual meeting September 2014.

**RD Sharing:** virtual workgroup of RDs to create a session for WSC 2016 with a focus toward unity.

**NAWS Sustainability:** an effort to ensure the long-term viability of NA World Services; outlined in the Strategic Plan.

**Evaluation of the Literature Distribution System:** a long overdue project; particulars are in the Strategic Plan.

**Service System:** will be hosting two webinars focused toward local implementation of LSB and GSF for members who are in the process, and for members who are interested in beginning the process. Creation of a succinct pamphlet to explain “What is the SSP?”

**Reaching Out Workgroup:** membership is comprised of H&I trusted servants who assist with the periodical for incarcerated members and H&I committees.

**The NA Way Workgroup:** international advisory board for the Fellowship’s recovery journal.

**Planning Our Future:** later in this conference cycle we will implement this virtual workgroup.

**Webinars:** Participation in our webinars continues to increase. ## Conference Participants Discussion Board

I have been monitoring this board. I post very sparingly. There are some of the topics that are out there.

The things I see posted vary from venting to constructive conversation. We struggle with a new world of social media. There are several Facebook pages that WSC participants keep up with. With all of this bandwidth it’s hard to keep up or even know what to follow.

## Multi Zonal Forum

Ray and I are headed to St. Louis next weekend for a Multi Zonal forum. We will learn more about the prevailing fellowship landscape.

## Unauthorized literature

I reported in my last report that “some members and some undisclosed area service committees have been reproducing and distributing a new version of the Basic Text.” Our literature falls under what is known as The Fellowship Intellectual Property Trust. The FIPT allows groups to make limited reproductions of NA literature for use in their meetings, but not for distribution. Individual members and service committees may not do so without permission from NAWS. In the last month World Services put out a memo on the situation. It outlines how there has been a campaign by some members to “join forces, obtain free or low cost literature and distribute it.” They have challenged the fellowship to take them to court. They are attempting to force us to spend funds to defend our copy write in court. This is money we need for translations or outreach or some other support of addicts.

“The NA groups, as owners of NA’s copyrights, and NA World Services, as trustees in the Fellowship Intellectual Property Trust, are partners in the effort to protect NA’s copyright. We are asking that you embrace this partnership and remember that NA groups and members have the

right and responsibility to demand that those who would reprint or modify NA literature refrain from doing so.”

## **Miscellaneous**

We are aware that there are two groups of members outside of our service body who are trying to form some different service bodies. This is some verbage taken from their web sites.

### **Global Anonymous Services Inc.**

Purpose:

To return the voice back to NA members and its chosen service body.

This group is having a conference in Jacksonville Florida in November.

### **The United States Service Conference of Narcotics Anonymous (USSC)**

The purpose of the USSCNA is to come together in unity to fulfill the service needs of our member bodies as directed by the spiritual conscience of the groups that have created it.

#### **Additional Feedback**

There is a link that has been started by some members (called the Voices of NA) that were part of the USSC and splintered off. These people are critical of the USSC.

We will keep you informed as we see anything that is of interest to this body.

#### **Insurance Business since June 2014, Region Meeting**

- Zero claims filed (this includes the annual convention).
- Zero home groups and/or areas obtained Certificates of Insurance.
- At this time, we have just a few days remaining on our existing policy before it expires on September 27, 2014. The renewal policy has been offered by the same underwriters and contains identical coverage's to last year. I talked to Arnezia and she stated that payment will be sent within the next few days. Since there is no such thing as 30 day grace period for renewal of general liability policies, I have asked Russ our Broker-Agent and the admin panel for suggestions on how we might implement a failsafe procedure to assure that our policy is paid on time. I greatly appreciate any suggestions from the floor as well.
- Since our last region meeting, I completed a rough draft on a policy and procedure manual for the insurance liaison position. I have secured two very talented and gifted writers to be on the review and edit team. The first of these will be cleaning up many of my verb tense agreements and countless dangling modifiers. The last of

these will then read from cover to cover, the manual for its simplicity, ease of use and understanding.

It is my goal to have the manual completed by next region in December.

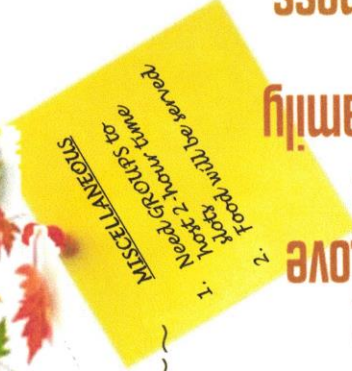

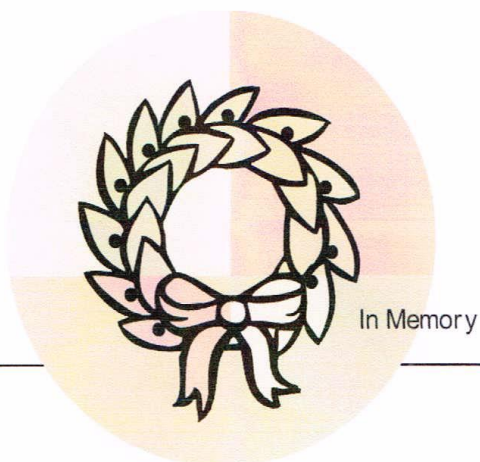
