GRSCNA Administration Meeting Minutes

Opened at 11:03 am by Frank S.

Attendance:

Frank S. Ray L. Mel N. Karen J. David C. Hugh R. James M. Carl H.

Storage unit was paid for 3 months per Fred C. There was a receipt emailed to secretary for a total of \$317.00 – this included late fees, lien fees, & certified mail costs of \$110. The treasurer was unable to attend this meeting therefore the discussion was tabled until she was available. There was some discussion about down-sizing. It was suggested to table this until the September region as the Archivist position could possibly be filled by then.

There was some concern over the minutes not being completed for March. The team acknowledged that there were technical problems as well as some unresolved issues amongst the administration committee. These issues were discussed openly and all parties involved took responsibility for their part. This included the secretary admitting to allowing the actions of other trusted servants on the administration committee to rent space in her head. She has processed this and made a commitment to not let what others do affect her that way and to also not co-sign manipulative and self-serving behavior, including her own. The computers that the body had agreed for the region to provide to the secretary and the treasurer were purchased. The treasurer would give the secretary the computer ordered for her when she arrives.

There was a grievance letter presented based on the 10th Concept by a member who wanted to let their concerns be heard and who was seeking guidance from the administration committee. The letter stated that they believed they were blocked from being elected to the Program chair, which they believed could and should have been the proper succession of service as she had served the previous year as the Program Vice-chair. The member was then nominated for many of the other open positions that were needed on the CPP and she was and the CPP body did not vote her into any of them. It was after all that effort that the hospitality chair offered this member the position of vice-chair on her committee and she agreed. This created a committee consisting of the only African-American members on the CPP committee. The member believes she suffered unfair treatment as she had met the requirements for all of the positions she had been nominated for. The administration committee recommended that this grievance be presented to GRC Inc. as her first line of defense and if she was not happy with her outcome there to please bring it back before the regional body.

There was discussion of the potential risk possibilities for that creates spikes in our insurance. Would it be unreasonable to request GRCNA and other large functions in the region to provide for their own coverage? There are weekend/special event rates for around \$200 for \$1,000,000 coverage. Even with the extra coverage there is still the potential that the region could have partial responsibility for any claims made.

There was an email sent from Lisa S. stating that she wanted to withdraw her request to allow the election to go forward in her absence for her nomination to policy chair. It would be announced at GSR/RCM Issues that this position was still open and accepting nominations.

GSR/RCM Issues Meeting Minutes

Why has the administration committee taken it upon themselves to tell the body what they are going to do? What happened to the concept that NA was built on - that the groups provide the direction that they want their areas and region to function?

Melissa N. was introduced to the body as a spectator to see if she wanted to take a service position. She is looking at Secretary Alternate. She was welcomed and began to informally assist with the secretarial duties.

There was some concern surrounding the email received from Lisa S. stating that she wanted to withdraw her consent to move forward with the vote for her nomination as Policy Chair in her absence. The letter stated that she was concerned about how business had been handled by the region and that she wanted to make the body aware of her concerns, plans and expectations before she could be voted in and accept the position. The RCMs were informed that the position was still open for any other nominations. (Email attached)

Why are we holding onto a storage unit that only has three boxes in it? There was some concerned expressed that the admin team making decisions without getting the input of the body. The body questioned why the decision to table the issue of the storage unit was made by the administration. The secretary presented the pictures that the body had asked her to obtain of the contents of the unit. There was discussion that there was a need to go through the contents of the storage unit to consolidate and organize the items in there and to inventory it. This task would help determine the amount of space that was actually needed. The secretary and the potential secretary alternate discussed doing this on the Friday before the region weekend in September.

I attended the NEGANA convention in Cumming. I attended the H&I workshop and they did an excellent job. The room was packed.

Our service committee continues to struggle with the 9am start time. Today we had 4 Areas on time; CSRA, ENA, NEGA, PIEDMONT. 4 more showed up 1 hour late; COASTAL, MIDTOWN, N.ATL, SLCA. We miss CFRA, EASTEND, MARIETTA, S.ATL, S.C.GA, S.GA and WESTEND. Please ask your Area H&I chairperson to send in absentee report as we don't know what is happening in your Area.

Our next Regional H&I learning day is being hosted by the Midtown Area with the tentative schedule for September or October of 2015.

The Savannah Low Country Area returned the receipts from our January Regional H&I learning day. They we're absent at our last Regional meeting.

We nominated and elected Gregory B. as our Vice Chairperson to fill the vacant position. He is from Savannah.

The GA Region Bridge Program helped 5 inmates last quarter. We've now assisted 98 inmates since February of 2012. Through our contact at the GDC we now have the ability to get our inmate "request" forms to all facilities. Please continue to ask members of your group, ASC and subcommittees to sign up to be a temporary contract. Currently we have 115 members in our list. Unfortunately they aren't spread across the state as we'd hoped. We need sign ups from WestEnd, South GA, South Central GA, Piedmont, Marietta and Central Savannah River Areas. Some of the Areas listed have 0.

We are piping in World Unity Day broadcast to inmates at Hayes State Prison in Summerville GA.

We are working with the GDC, GRCNA committee and some PR members from NAWS and FRSCNA to live stream the main speaker from GRCNA to GDC inmates.

Our GDC contact suggests utilizing them to contact new state facilities to get clearance, find contacts and get certifications. They suggest our current practices have little to no chance of success. FYI, We already new that.

OPEN FORUM

Is there any interest in doing a workshop on the expungement process? The body shows some interest.

How are we going to address newcomers that attend the convention versus clients that attend through a treatment center? There were over 200 newcomer packets available on (and handed out) at the last GRCNA. The convention committee defines a newcomer as 90 days or less. Treatments are handled in a completely different manner. They are taken care of by the facility they are coming with. The convention has never turned an addict away.

There is a need for transparency among the trusted servants, it is considered spiritual in nature. At the last region there was a voiced concern directed at the administration committee about their lack of transparency, that they are operating from a behind the scenes position. There is some validity to that concern. There is a lack of communication; there are some conversations that are being conducted by a select few of the committee concerning the body as a whole. The "us" and "them" are a result of this lack of transparency. This is not what Narcotics Anonymous is – this is a "we" program. There are position duties clearly outlined in our policy and we need to stick to what the groups have directed us to do. Trusted servants need to fulfill their duties and not attempt to do other people's duties. We need to stay within the boundaries of our positions and lend a hand when we are asked. There needs to better communication. Anonymity requires me to remember that every member is equal to me, that they are as valid as I am, and that they are as important as I tend to think I am. If a trusted servant, or any member for that matter, has a concern it is important that I allow them to be heard. On the hand, I need to be able to share my concerns without them being minimized through denial or rationalization.

What is the purpose of the zones? The logical solution appears to be to restructure it to allow it to function as a learning tool. If we go to zonal structure it has to be effective.
