Aside from that I am still participating as a member of the general admin as much as necessary at the regional meeting and working on getting to know how to be an effective facilitator.

### **Secretary Report**

### Dear Family-

Since the last region, Mel and I have closely worked together to prepare her for the transition from Secretary Alt to Secretary. She prepared the minutes with minimal assistance and just needed some guidance on tying up a few loose ends. I am absolutely convinced she will do a great job as your Secretary over the next year. Please be loving, patient, and kind to her.

As many of you saw in your inbox this morning, I completed the March 2015 minutes. All of the minutes are uploaded to the website in their full version. You have to be logged in to see them. If you do not log in to the website only the redacted versions are visible. Bill D. has been working hand in hand with me to make sure that we got this done before I left this position. The redacted versions that are still not uploaded are June 2014, March 2015, and March 2016. These will be up in the near future. Each document must be redacted individually and this takes time. Also, we have uploaded all of the current and revised forms in an editable form on the website. This is to help us keep our communication streamlined and to make it as easy as possible for all of us!

One thing I noticed is that we have gotten several unable to deliver messages when we send out mass emails. Please, Please, Please make sure your email addresses are printed clear and exactly as they need to be entered on the registry when it goes around for corrections. 

# 2016 World Service Conference (WSC) report

- 112-seated regions had delegates attending 65 from the US, 5 from Canada, and 42 from outside the US and Canada.
- 88 Alternate Delegates attended 61 from the US, 4 from Canada, and 23 from outside of the US or Canada.
- > Make-up of the conference was 148 men and 68 women, including World Board members.
- > El Salvador, Greater Illinois and Iran were not able to attend
- > Dominican Republic participated as a seated region for first time
- This Conference made the decision to seat three regions: Grande São Paulo Region, HOW Region, and Rio de Janeiro Region at the WSC.

### Growth of NA

Regions were asked if membership seemed to be growing, shrinking, or staying the same: 59% report that they are growing, 36% report they are staying the same, and 5% report that they are shrinking.



# Fellowship Development (FD) and Outreach

52 communities have a regional FD or outreach committee as part of their regional body, and 63 regions have some form of FD, even if it is not a formal committee. Also, 80 regions have had discussion about where NA does not exist in their communities.

- Regions sponsoring neighbouring regions
- Reaching out to outlying groups to offer help and support
- Spanish groups work with Latin American Zonal Forum to help NA communities in Haiti




107 regions reported about PR efforts.

The amount of regions and areas using CBDM is rising slowly.







# Literature Survey

The charts below represent the choices that the BC region prioritized:


The following charts show what were prioritized by all the regions that participated, along with the responses from individuals.




- Will publish Guiding Principles as first priority

### **Business Session Processes**

The WSC has been in transition to CBDM since 2002, and we keep trying new ways to make this a reality. We find what works and what we never want to try again. We are trying to aim for more discussion, less debate, and less formal, in order to hear from more voices. As there are no current guidelines for CBDM at the WSC, we have been developing as we go.

Who votes when?

- There is only one voice per region per issue: either the RD or the alternate can speak, but not both for the same issue
- CAR motions: only RDs vote, not ADs or the World Board
- New business motions and proposals: RDs and the World Board
- Elections: RDs and the World Board
- Moving forward: RDs and the World Board

The process is this:

- Item is introduced and straw polled, the straw poll results are announced as: Unanimous support, strong support, support, lack of support, strong lack of support or no support
- Amending motions are heard, straw polled and discussed before the original motion is discussed
- If a motion/proposal has more than 80% in favor or less than 20% in support, then the motion is considered consensus support or consensus lack of support.
  - If this happens, we hear from 2 members who are not part of the consensus, then straw poll again. If consensus support or consensus not in support remains, discussion ends.
- If a motion/proposal does not have consensus, then discussion will then be had on the idea, with possibilities for amending the item; change is straw polled
- If change is supported, item is now revised
- After discussion, straw poll again (final)

If motions are changed during the straw poll and discussion process, the amended motion will be introduced in formal voting.

All motions will be introduced in formal business for formal voting:

- This is a Robert's Rules of Order process
- 3 in favor, 3 opposed
- All Regional motions need a seconder

# Old Business

The process of old business motions and amending proposals started at 9am on Monday, and concluded at 6 pm on Tuesday. On Monday night, we ended at 1 am. We resumed at 9 am on Tuesday. There were 20 Old Business motions, 16 amendment proposals to those 20 motions.

During the discussion session, first the original motion was discussed, then any regional proposals which were brought forward to amend the original motion.

Vote counts are listed as For/Against/Abstain/Present not voting

### Below are all the Old Business motions that were approved:

### World Board Motions

Started at 9 am Monday until 12:45 am, resumed Tuesday 9 am and concluded at 5:50 pm.

These are the motions that were approved:

Motion #1: It was M/C World Board

To approve the book contained in Addendum A, "Guiding Principles: The Spirit of Our Traditions," as Fellowship-approved recovery literature.

Intent: To have an additional piece of Fellowship-approved material available about our Traditions for use by NA members, groups, and service committees.

Carried 110-1-1-0

There was a proposal to amend the book:

Proposal R Greater New York Region

To amend Motion 1 to change one word in the Introduction to Guiding Principles on page 63 of the 2016 CAR, 4th paragraph, 3rd sentence. What now reads "Earlier programs for addicts, including some bearing the same name, did not <u>practice</u> Traditions and did not survive," would be changed to "Earlier programs for addicts, including some bearing the same name, did not <u>have</u> Traditions and did not survive."

Intent: To accurately reflect the history referred to in the introduction.

The initial straw poll results were **50-59-1-2**; in discussion, the following points were brought up: this literature was approved by the fellowship thru the CAR, and amending it on the floor of the conference would change the perception of this literature from "fellowship approved" to "conference approved" by many members. It was also brought up that there are many members from many regions that are very interested in our history, and this would need to be researched before being changed.

After this discussion, the vote changed drastically, to **22-87-2-1**. The amending motion failed.

Motion #2A: It was M/C World Board

To approve the following change to the World Board External Guidelines contained in A Guide to World Services in NA (GWSNA):

◆To change the size of the Board from up to 18 members to up to 15 members.

Intent: To reduce the maximum size of the World Board for effectiveness and financial sustainability; Carried 104-8-0-0

Motion #2b World Board

To approve the following change to the World Board External Guidelines contained in A Guide to World Services in NA (GWSNA):

◆To remove the obligation for staggered terms if more than eight (8) members are elected at one time.

Intent: To eliminate the requirement for terms of less than six years for some members. **Carried 106-6-0-0** 

Motion #2c World Board

To approve the following change to the World Board External Guidelines contained in *A Guide to World Services in NA (GWSNA)*:

♦ To change the limitation from two consecutive terms to two terms in a lifetime.

Intent: To limit the number of terms for which any member is eligible for election to the World Board. **Carried 112-0-0-0** 

### **Regional Motions**

Motion #3 Eastern New York Region / Second: Chicagoland Region

That the NA World Board develop a project plan which includes a budget and timeline to create an informational pamphlet specifically about mental illness and recovery for consideration at the 2018 World Service Conference.

Intent: To have a fellowship approved, clear Narcotics Anonymous message about the important issue of mental illness and recovery that is available in a pamphlet format. **Carried 93-17-1-0** 

Motion #11 Western Russia Region / Second: Finland Region

To allow a delegate from any currently existing Zonal Forum who requests it to be seated at the WSC 2018 as a non-voting participant for one conference only. The expense of attendance will be the responsibility of the Zonal Forum and not the WSC.

Intent: To involve zones at the WSC. Carried 72-29-2-4

The words in **red** are the amendments which the conference approved in the discussion portion.

All other regional motions failed

### **Translations**

NA is currently in 130 countries, and we speak 76 languages. Translation contractors are very costly; the communities that are most in need of assistance are typically those that are least able to contribute.

If we are successful in sharing our message worldwide, we will always need a lot of translations done. We look at how much we can translate in any given year, for the least amount of cost.


We now have IP#1 in both Zulu, Estonian, Amharic and Cree, and the Introductory Guide to NA in Chinese.

There are 80 languages spoken currently in NA, and this is what has been translated so far:

- IPs/SPs 47 languages
- Booklets 27 languages
- Books 29 languages

Farsi is the only non-English communities have all literature translated; Spanish is close, with only Miracles Happen not translated.

### Literature Distribution

The goal of NAWS is to ensure reliable flow of literature by navigating customs, duties and politics when necessary.

Approximately 35 % of all NA literature is distributed through regional service offices; the rest is distributed by NAWS, through local distribution centers when possible. There are three distribution centers: in Canada, Belgium, and India.

We have agreements with locations in Egypt, Russia, Argentina, and Brazil.

Tradition Nine: "*NA, as such, ought never be organized, but we may create service boards or committees directly responsible to those they serve"*, still applies to regional service offices, even if they have incorporated. There is no such thing as an autonomous service corporation.

### **WCNA**

WCNA 36:

- There were a lot of unforeseen costs that came up at the last minute
- Renegotiations were happening very close to the start date

- Three companies did not provide the services they were contracted to
- The Brazilian support committee were a very hardworking group of individuals, trying their best to make this a successful event.
- Despite disappointing financials, it could have been worse; they did the best they could.
- There was discussion about cancelling the event, but due to cancellation clauses, it would have cost as much to cancel it as it did to continue forward.
- The boon to the local fellowship and the Brazilian fellowship as a whole made the loss easier to take

### WCNA future:

- 2018 Orlando, Florida: exact dates still to be determined
- 2021: Asia-Pacific/Middle East/Africa: plan to make it accessible to the Iranian fellowship
  - It is impossible to predict the influence of political change or economic forecasting
  - Prudence says we provide a backup plan, to not put all our eggs in one basket at this time.
  - Final decision will be made in the next 12 18 months
- 2024: North America

### Assisting other NA fellowships:

There are ongoing efforts where groups/areas/regions are sending direct assistance to some communities that struggle. There are numerous communities where the addicts in the rooms cannot afford a Basic Text, the groups cannot afford to give them away, and stable home group members cannot afford to purchase them for newcomers either.

These communities exist all over the world, in North America, Europe and everywhere else.

Sweden supported their neighboring community of Poland by sponsoring them: they attended, assisted with fundraising efforts, speaker jams, purchased the Basic Text in Polish for the members of the Poland fellowship.

If your group/area is interested in this, you can contact NAWS for a list of communities that could use assistance.

### Strategic Plan and Project Plans:

This was supposed to be a separate session, but due to time constraints, it was eliminated. A plan that is built together creates the greatest results. When the World Board and the WSC work together, it is a great partnership.

An aligned planning cycle helps with this. If a region wants to give input, scanning should be done in summer of 2017 to give input by fall 2017. Everyone needs to be dealing with the same framework in order for us to plan together, it needs to be standardized.

# **Public Relations**

There have been some great strides made in Public Relations around the globe over the past cycle, with a lot of local efforts made, including radio and TV Public Service Announcements, bus signs, and many other types of reaching out.

If we think back to how we arrived in NA, maybe through treatment, detox, or prison, NA brought in meetings; by that sharing of information, we helped to grow NA.

Reaching Out is now 30 years old, with 13,379 e-subscriptions and 12, 807 paper subscriptions. Prison staff like to give this one out, because it shows the inmates that it is possible to get and stay clean inside.

### **Professional Events attended:**

### NADC: National Association of Drug Court Professionals Conference

• This is the largest growing conference, with over 5000 in participation. There are more drugs than ever throughout the US.

### ASAM: American Society of Addiction Medicine:

- Last year we had 40% of the attending doctors talk to us, wanting us to change from complete abstinence
- This year we had 80% of the doctors requesting the same thing
- A number of the DRs were not nice about this request, they are pushing back
- The doctors were sending their clients to AA instead of us, but AA got fed up and complained to the doctors
- As a result, we were invited to discuss the 12 steps in a workshop at this conference

### IFNGO: International Federation of Non-Government Organizations:

- This conference wasn't focused on treatment, but they are (sort of) collaborating about treatment. Treatment in Cambodia is not very established, but it is getting better in Thailand.
- There is a change in how addicts are treated now: the government is looking at them again as people who need help

### Vietnam:

- NAWS met two doctors from Vietnam when they were in Tokyo; we were asked to meet with them in Hanoi
- We met at the embassy; they do not quite like us or our ideals, because they do not allow addicts to congregate at all.
- They are trying to find ways to combat their HIV epidemic, and we are one option
- NAWs is hoping to make a follow up trip in the next year

# Fellowship Development

NA now speaks 80 different languages, and our literature is published in 42 languages. The needs are more than double now than they were 10-15 years ago.

Every 10 seconds someone is saying the Serenity Prayer somewhere.





We are not missionaries, some things are better handled by a neighbouring region or a zone. NAWS used to do World-wide workshops, which connected places that weren't connected at all. Now all of these places are connected by zones, and that is where the learning events happen.

- NAWS starts the process and makes the introductions, then the members take it from there.
- Russia was a prime example of this, they are now all connected thru the Russian zone.
- NAWS brought together Iran and other Arab nations, now they have Arabic literature
- They started the Middle East convention, and are talking about a Middle East zone *North America*

    - Nepal requested a fellowship development trip, requesting we help them to reinvigorate their community after the earthquake. We attended, and had it in a part of eastern Nepal, which borders on Bangladesh, NEFR and another country. It was thought that 60 people would attend, but over 200 people showed up.
    - There were people sitting in the window sills; did welcoming all members and collaboration; made commitments to continue with translations
  - 2 Conventions
  - 2 Literature distribution Centre visits
- Did a presentation at Queen's Institute Drug Institution: did a presentation to over 100 professionals a few years back, and now we have a Basic Text in Thai for them to distribute
- The first Living Clean meeting is starting up in Katmandu

- Workshop was done in collaboration with the EDM.
- The most important topic was H&I: a list was made of all the institutions, and each place was visited; they talked about strengths and weaknesses


### Ukraine:

- NA fellowship is about 25 years old here
- Having talks with the government about the possibility of drug courts
- NAWS provided information on how this works in the US

### Kazakhstan:

- Is a very large country situated between Afghanistan and Russia, with a small fellowship
- When NAWS first travelled there, the local fellowship had no idea how to get together or how to start providing services.
- The fellowship is only 7 years old

## Western Europe:




Attendance at:

- They do FD very well, by talking to each other on a regular basis: connecting and collaborating
  - They sponsor each other: regions sponsoring

  - There was funding assistance available to anyone that was not a delegate: H&I, translations, etc, to get more people attending
  - Over 100 people from over 23 countries attended

Having the NA communities meet and work

together has helped them to stabilize, and has tremendously helped get translation going

- $\bigcirc$  At the African convention, members attending were asked where they were from. If there was no meeting there, the members were given a starter kit to assist. There are now 8 new meetings in Daar-Es-Salaam because of this initiative
- The Basic Text in Swahili will be completed within the next week or so. There was a bad translation of the baby blue version brought over and flooded the continent, then a bad translation of the 2<sup>nd</sup> edition was taken. They are now getting the real version. They need to read the true NA message, and not have to deal with the North American politics

## Budget

Highlights:

- Low estimate on projected sales of Guiding Principles, in order to not depend on guesstimated income; we can judge income on this better after a few years of sales
- Income from Living Clean has plateaued; despite many Living Clean meetings, the sales have dropped off
- Currently have enough funds in reserve to cover 3.8 months of costs

# FIPT and NA Literature

FIPT – Fellowship Intellectual Property Trust: This assembly, the WSC is the trustee of the FIPT There are three main issues facing us today:

- 1. Illicit literature/grey books
- 2. Registering group with NAWS that use non NA approved literature
- 3. Area/Regional websites posting recovery literature

## Illicit Literature:

- These books combine previous versions of the Basic Text. They are the 3<sup>rd</sup> edition revised with the essays on the 4<sup>th</sup> and 9<sup>th</sup> Traditions taken from the 2<sup>nd</sup> edition. This language places the NA service structure outside of NA
- This combination was never an approved version of the Basic Text
- When the fellowship approved the 6<sup>th</sup> edition, that became the only legal version for sale and distribution, and sale and distribution is strictly thru NAWS
- The production of this hybrid version conflicts with the conscience of the fellowship
- This violates the copyright
- Literature for personal use by our members is okay to modify: for example, modifying the Step Working Guide, bringing an older version of a book to a step study meeting; these are all okay
- We're not talking about personal use, but strictly about sale and distribution
- There were two bulletins created and sent out this cycle to address this issue:
  - Bulletin about NA copyrights and literature: <u>http://www.na.org/admin/include/spaw2/uploads/pdf/bulletins/NA%20Literature%20a</u> <u>nd%20Copyrights.pdf</u> and
  - Group Conscience and NA Literature: <u>http://www.na.org/admin/include/spaw2/uploads/pdf/bulletins/Group\_Conscience\_an\_d\_NA\_Literature.pdf</u>
- As long as our members stay silent and allow this continue, nothing will change
- Cease and desist letters have been sent, threats of lawsuits have been made; this has done nothing to stop this behaviour; we have been told "please take us to court"
- There was a lawsuit in 1991 about the exact same issue, which did not resolve the issue; it seems unlikely that legal action would change the behaviour now
- At the 1991 WSC, there were motions brought to the floor:
  - 1. To reconsider which edition of the Basic Text should be produced; this motion failed
  - 2. To produce the edition of the text that was ratified by the WSC; this motion failed
  - 3. To obtain a group-by-group tally of all registered groups on the above motions; this motion failed
- The 6<sup>th</sup> edition is the only edition approved for NAWS production and distribution is solely through NAWS; the only exception is translated literature that has not been updated yet
- The conscience of the fellowship to date has been consistent with the FIPT

• People continue to defy the guidance of the FIPT; this is in direct conflict with the will of the fellowship, as well as the law

## Grey Form and Group Registration:

- The Grey form is the original draft copy of the Basic Text, before the changes that were approved by the conference.
- This was never meant to be used in meetings, it is strictly a historical document.
- Review and input drafts are not intended for meeting use and are not fellowship approved

## Group Registration:

- Groups are not required to register with NAWS, but it is encouraged, when registered they are in the online meeting search, and the meeting locator app
- Quite often the name of the group is indicative of a group not following the FIPT: *ex. The Grey Group*
- Consideration for registration (taken from the Group Booklet):
  - Group name (like First Baptist NA group)
  - Lack of NA terminology (ex. Not knowing the ASC)
  - Group location (individual's home)
  - Non-NA member registration (treatment professional, pastor)
  - Unusual access requirements (must also be a member of...)
- Where there are obvious concerns, NAWS reaches out to the group to get clarity which usually resolves most common issues
- A number of groups have not been registered recently because of the Grey Form issue; they tried to register as a "Grey form study"

## ASC/RSC Posting Literature online:

- Duplication by paper or digital is not permitted by the FIPT
- The ASCs doing this have been asked numerous times to remove the posted literature
- There are currently 12-15 websites that have our book length pieces on them
- We can contact the ISP (Internet Service Provider) and send a copy of the FIPT, showing that the posted items are done illegally. The ISP will most likely shut down the site.
- The concerns raised were that if the sites are shut down then addicts won't be able to find meetings, but this is not the case if the meetings are listed on the NAWS database

The Ecuador RD shared that their region usually sells a literature through their groups and region, but due to illicit literature landing in their fellowship, they have only \$1500 in book sales in the past 6 months. They have a debt with NAWS for over \$20,000, and this is directly affecting their ability to repay that debt. *The day after sharing this information, we were informed that the information had been recorded and posted online, and the RD had received threats from people back home that were involved in the selling of the illicit literature.* 

This is no longer just a US problem: this is happening in 26-27 US regions, 2 regions it the APF, 2 in the LZF, and 1 in Africa

## **Questions posed to the Conference:**

1. Do we believe that the Fellowship still affirms the rules we have agreed on in the FIPT?

95% yes / 5% no

- Should we register and list on the meeting locator, NA groups that clearly intend to use material that is not NA-Fellowship approved?
   26% yes / 74% no
- Should we take action to remove NA recovery literature from ASC/RSC sites, even if it means shutting down the site? (This may require ongoing action if a new site is created.) 71% yes / 29% no

Discussion was had about these issues, trying to come up with some solutions:

## Discussion: Illicit texts: what more can NAWS do:

Educate And Inform:

- Educate the fellowship
- IDT about the issue
- Make workshops about gratitude and responsibility to not buy illicit literature
- Create a guide line booklet to distribute in the groups
- Create a resource for service bodies to use with institutions that are using illicit literature
- Fellowship dialogue about group conscience and "fellowship approved"

### Dialogue/Mediation

- Bring parties together for mediation
- Dialogue with NAWs and those who are behind the issue

Legal Action

- Legal or other action against companies printing illicit literature
- Litigation

## **Registering Groups Using Illicit Literature**

Educate, Clarify, Inform

- Define illicit literature and what is approved lit
- IDT about the issue
- Go to the meeting ask to remove materials and say why
- Discuss with groups using non-NA lit: do they understand this is outside our principles
- Clear definition of NA group/meeting

Don't Register/Remove

- Not register them, give them information about FIPT
- Warn them first, remove them if they aren't willing to comply with the Group Booklet

### Revise Literature/Create New Literature

- Education at the group level: update Group Booklet
- Have an IP to help educate members

Register

- Register the groups and inform them, using spiritual principles
- Send approved literature to the group when they ask for registration

## ASC/RSC Websites:

Ask First, Then Take Further Action

- Notice prior to action
- RSC web servant can remove the ASC that has PDFs from the regional site
- Take action, close down the website by contacting the ISP

Educate/Inform

- Education: raise awareness about FIPT issues
- Educate the fellowship about what actions can be taken
- Generate letter from WSC not just from NAWs: simple, comprehensible
- Broad based "campaign" videos, posters, etc to educate members on consequences with concrete examples
- Contact please stop

Ask, But Don't Take Action That May Remove Meeting Info

- Be <u>very</u> careful about removing meetings
- Continued communication but don't affect the primary purpose of providing meeting info
- Don't dare remove (close down) website

Work With Other Local Service Bodies

- Partner with RSCs to encourage ASCs to comply with FIPT and protect our literature
- Explore an incentive package to those ASC/RSCs that are willing to listen

## Moving Forward Session, had final discussion of options:

- Do we want to say that NA groups use current editions of NA Fellowship-approved literature? 61% yes / 33% no
- Are former editions of NA Fellowship-approved literature different in your mind than the hybrid versions that have been created and never approved in that form?
   79% yes / 10% no
- 3. Do we want an additional statement from WSC 2016?<br/>Two straw polls were taken on this issue during the Moving Forward session.First PollSecond Poll62% yes / 31% no66% yes / 34% no

We are proposing that we poll today and craft a statement to be sent to delegates for a 90-day review and approval. Or a 60-day review and 30-day approval.

The Future of the WSC Content provided by James (RDA) Planning our future and the needs of NA workshop began with a review of our goals for the upcoming sessions. This was the first of 3 sessions of the future of the WSC. Providing some historical background of how we got to where we are today. In early World Service Conferences there were 45 seated regions, 6 of these non US and today 112 seated and 45 non US. We are in need of strategies to effectively meet our worldwide fellowship. The size and effectiveness of the conference is becoming more challenging and consensus is more difficult. Having small breakouts provides some opportunities. The conference costs for WSC 2014 were \$465.000 and this is only for lodging, transportation and food. It does not include room setup, AV equipment and staffing. Planning our future sessions at the 2014 WSC aimed at identifying a path forward and possibilities for a sustainable conference. No decisions were made but common ideas surfaced. An NA needs mind map was developed at the 2014 WSC examining the needs of NA. At the 2016 WSC delegates broke off in to breakout rooms to review the previous conferences work and to see if there was anything missing or new to be added. Items in red are some of the additions by this year's conference participants.

- 1. Spiritually Based processes.
  - Make service more attractive
- 2. Collaboration
  - Synchronize planning cycles
- 3. Inclusivity/Diversity
  - Include Rural and Isolated areas
- 4. Sustainability/Resources
  - 7<sup>th</sup> Tradition workshops for all levels
- 5. Translations

- 6. Communication
- 7. Leadership/Mentorship/Training
  - Explore ideas for Service Sponsorship
  - Make better use of available skills
  - Encourage recovery principles in service
- 8. Shared Global Perspective
  - Conflict resolution
  - Issues affecting NA as a whole

We also looked at the mind map of why we come together.

- 1. Oversight
- 2. Legal Responsibilities
- 3. Community Building.
- 4. Vision and Purpose.
  - Unified PR approaches
  - Conflict resolution
- 5. Global Coordination/Sharing Best Practices
  - Encouraging service sponsorship
  - Bringing recovery in to service
  - Making best use of existing skills and talent
  - Syncing planning cycles

A workgroup was formed to study the information from WSC 2104. There were 3 questions that came from this.

- 1. Do you agree with the discussion results that seemed to favour some form of zonal seating?
- 2. Would another form of seating be better- State/Nation/Province or something else?
- 3. What can we do to ensure an effective and sustainable WSC in the future?

The planning our future workshops over the week picked up from there and our further work will help to carry the conversation forward. The planning sessions helped us to provide a framework that will gave us questions to propose to the fellowship. Input from the regions will be in the 2018 CAR.

A poll was done to ask which regions had the conversations within their regions and it was 82 have and 29 had not. A second poll was done to explore other options, was there anything we wanted to do?

- 1. No change 18%
- 2. No change in representation but other changes such as delegates only at the WSC. 20%
- 3. Zonal seating, whether current zones or something else. 41%
- 4. Some other basis for change in representation, such as State/Nation or Province. 20%

Together as a Conference we need to begin clarifying what each of these options mean that we had prioritized to be able to present this information to the fellowship in the 2018 CAR. Some of the questions we asked during our second breakout sessions were as follows with the top ideas prioritized.

## **Option 1: Zonal Seating**

What specific ideas do you have for zonal seating? Existing zones? Something else? Number of delegates per zone? Ideas for/criteria for future seating of zones that request it?

### 7-10 Zones Geography/Language/Cultures

- Zones provide services; WSC does strategic planning
- Not necessarily zones as they currently exist, but some may remain the same
- Options for delegation:
   -Equal voting but different delegation: some zones have more delegates
   -Or equal delegations
  - -or proportional delegation based on # of meetings.

5 delegates per zone

- Existing zones with exception of US
- Allows for region splits
- Purpose defined by needs
- More resources for zones, less for WSC
- WSC meets less often- 3 year cycle

## **Option 3: Some other basis for change in representation**

What other ideas do you have for representation? What are the specifics of that idea? If not regions or zones, what type of seating at the WSC would be ideal?

Continental representation

- Rep for every continent and WSC every 3 years
- Use of technology between meetings
- Off year coming together as a continent (i.e. N America, S America, Asia, Africa, Europe.)
- Scalable and allows for growth
- Change by countries

Through working together for a shared understanding of our direction of where to go from here, we began to frame questions in order to gather the fellowships input. This was a daunting task as there were many differing viewpoints and time constraints due to old business sessions taking as a long as it did to complete.

Questions we asked ourselves to help us get where we need to be:

- 1. What would it take to get us to consensus?
- 2. What questions must we ask the fellowship about the future of these options?
- 3. How can we frame the discussion in a way that avoids the roadblocks, some of the regions encounter, when talking about trying to have this conversation with their regions?

Over the next 2 years the fellowship will be looking to expand and develop new ideas towards these and our other goals to improving the structure and the way we communicate at the World Service

Conference. The World Board has been directed by the fellowship to move forward to work toward building upon the work we have done at the 2016 WSC on planning our future. I look forward to seeing over the coming months the tools that are going to be made available to help us.

Email communication will be used as a tool to help us frame the questions moving forward

## New Business

New Business is when the project plans from the Conference Approval Track (CAT) and the NAWs budget were dealt with, as well as all new regional proposals.

There were 60 items to be dealt with in total:

- 8 budget related items including the project plan approvals
- 9 Seating items
- 7 Future of the WSC items

The session started at 9 am and concluded at 1 am with a motion to adjourn; there was a misunderstanding about this motion: the general thought seemed to be that if we adjourned we would pick up again the next day, but that is not the case; a motion to adjourn is to basically say that we are done business.

We did a straw poll only on the final proposals on Saturday afternoon; there was no discussion had on them, and the ones that had support were forwarded to the WB for action

### Proposal AJ South Florida Region

Fellowship Issue Discussion Topics (IDTs) will be selected based on the following process: By August 1 following the World Service Conference (WSC), NAWS will create a section on na.org for IDT submissions. Any member, group, area, region or zone will be able to add an item to the poll. Beginning February 1 in the year before the WSC the process of voting on the poll will start. Any member, group, area, region or zone will be able to vote on the choices in the poll. The poll will close on the final day as set by the Guide to World Services (GTWS) for regional motion submissions. The top six Issue Discussion Topics in the poll will be placed in the Conference Agenda Report and voted on in old business at the World Service Conference with the top three being the Issue Discussion Topics for that next conference cycle.

Intent: To have more direct and specifically defined fellowship involvement in the creation and selection of Fellowship Issue Discussion Topics.

Intent: To increase sustainability of WCNA.

Proposal BN Wisconsin Region

To create a workgroup who shall develop a methodology to assess the progress of NAWS since the creation of a single unified board as a result of the World Services Inventory conducted in the mid to late 1990's.

Intent: As a worldwide fellowship, we need to occasionally examine the performance of NAWS in order for the relationship of the worldwide fellowship and NAWS to remain focused and on course. This performance appraisal to be made by the worldwide fellowship appears to be overdue. This project will undoubtedly honor the theme of the 2016 WSC; Honesty, Trust, and Goodwill, thereby fostering unity and our common welfare which is in keeping with values and ideals alluded to in the First Tradition of Narcotics Anonymous.
